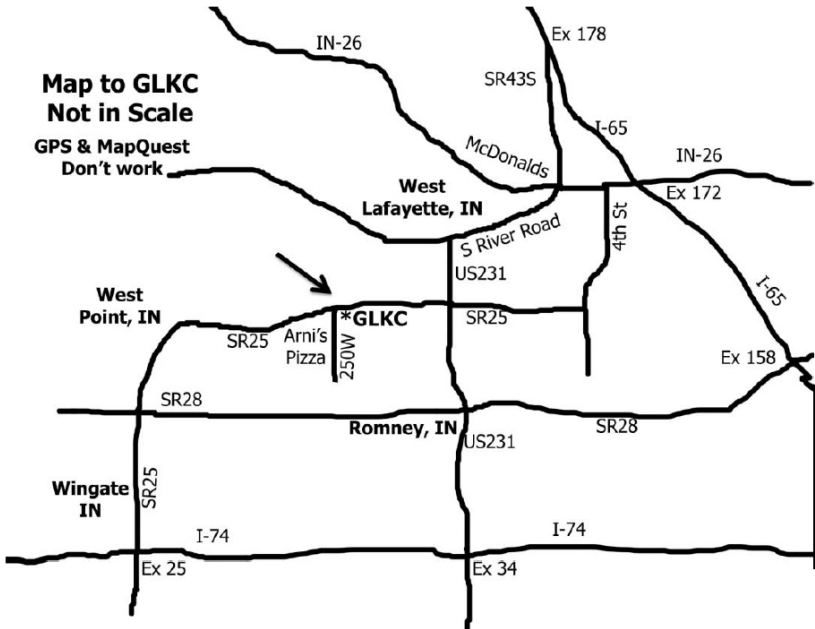

FROM THE NORTH... TAKE I-65 TO SR 43 S. WHEN YOU GET TO THE STOPLIGHT AT INDIANA 26 (TRAVELODGE, MCDONALDS), CONTINUE STRAIGHT AHEAD ONTO SOUTH RIVER ROAD. TURN LEFT ON US 231 SOUTH AND CROSS THE WABASH RIVER. TURN RIGHT ONTO SR 25 AND GO 1.8 MILES, TURN LEFT INTO THE DRIVEWAY IN FRONT OF THE CREAM-COLORED GLKC BUILDING. IF YOU GET TO 250 W, YOU HAVE GONE TOO FAR.

FROM INDIANAPOLIS AREA... TAKE I-65 (OR US 52) AND TURN LEFT (WEST) ONTO SR 28.. TURN RIGHT (NORTH) ON US 231. TURN LEFT ONTO SR 25 AND CONTINUE FOR 1.8 MILES. TURN LEFT INTO THE DRIVEWAY IN FRONT OF THE CREAM-COLORED GLKC BUILDING. IF YOU GET TO 250 W, YOU HAVE GONE TOO FAR.

FROM THE SOUTH... TAKE US 231 NORTH. TURN LEFT ONTO SR 25 AND GO 1.8 MILES, TURN LEFT INTO THE DRIVEWAY IN FRONT OF THE CREAM-COLORED GLKC BUILDING. IF YOU GET TO 250 W, YOU HAVE GONE TOO FAR.

FROM THE WEST... TAKE SR 25 TO THE TOWN OF SHADELAND. JUST PAST THE GAS STATION AND ARNI'S PIZZA AT 250 W, TURN LEFT INTO THE DRIVEWAY IN FRONT OF THE CREAM-COLORED GLKC BUILDING. IF YOU GET TO 250 W, YOU HAVE GONE TOO FAR.

## EXHIBITOR INFORMATION

All dogs must be on a short leash and under control while on trial grounds except while showing. Approved collars include flat snap or buckle collars of solid construction and leather or nylon leads. Limited slip martingale collars are allowed. Single piece slip collars/leads are allowed. Harnesses, with the exception of head-halter types, are allowed. Dogs MUST run "naked," without a collar/harness. Collars/harnesses which can be easily and quickly removed and replaced are strongly encouraged. NO flexi-leads allowed.

There is **NO SMOKING** in this facility or on the grounds. Please pick up after your dog.

**CHECK IN - REGISTRATION:** Building will open @ 5:15 PM. Judge's briefing will be at 5:40 PM. First run will be @ 6 PM. A judging schedule will be sent via email after entries close. If you do not have email, please enclose a stamped self-addressed envelope.

### **HEIGHT DIVISIONS:**

Dogs 13" and under, **Small**; Dogs 13.1 to 18", **Med**; Dogs over 18", **Large**

**RUNNING ORDER: Small to Large.** Dogs will be run in height order with dogs being handled by the same person separated into different staged groups.



Please bring weather appropriate gear. These trials will be held indoors but the facility can be affected by the outside temperature. Crating space is limited, please crate in designated areas only, and make sure your crate is secure as the dogs may be highly excited. Tarps or mats must be under crates. Please bring adequate water for you and your dogs. There is no food on-site, but there are numerous fast food restaurants within 5-10 minutes of the trial. There is an indoor restroom at the site.

**Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial.** Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from the competition by action of the Trial Committee. No entry fee will be refunded if the trial cannot open or be completed by means of riot, civil disturbance, fire, or an act of God, emergency, act of public enemy, or any other cause beyond the control of the organizing committee.
