***Please be responsible and pickup after your dogs!***



- Vehicles parked contrary to regulations will be subject to towing at owner's expense.
- All Handlers must pick up after their dogs. Anyone witnessed not cleaning up after their dogs will be requested to leave and no refunds given.
- All dogs must be kept on leash or crated at all times, except as allowed in the Show ring. NO FLEXI LEADS allowed inside the building.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, and any communicable diseases, and have appropriate vaccinations.

These trials will be held indoors but the facility can be affected by the outside temperature. Please crate in designated areas only, and make sure your crate is secure as the dogs may be highly excited. Tarps or mats must be under crates. Please bring adequate water for you and your dogs. There is no food on-site, but there are numerous fast food restaurants within 5-10 minutes of the trial. There is an indoor restroom at the site.

**Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial.** Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from the competition by action of the Trial Committee. No entry fee will be refunded if the trial cannot open or be completed by means of riot, civil disturbance, fire, or an act of God, emergency, act of public enemy, or any other cause beyond the control of the organizing committee.

**AWARDS:**

Qualifying ribbons will be awarded for all qualifiers in all classes, including Instinct. Placement ribbons will be awarded for 1st through 4th place in the Novice, Open, Senior, and Master classes in each height division. A ribbon will be awarded for those who obtain a new title in Instinct. New title rosettes will be awarded to those who obtain a new title in Novice, Open, Senior, and Master. A special rosette will be awarded to those who earn a RATCH or RATCHX\*.

*\*If you anticipate earning a RATCH at our trial, please let us know no later than December 31<sup>st</sup> so that we have your special prize available.*
